Meeting and Procedure:

The Committee will meet upon receipt of any Complaint by the Chief Operating Officer of Campus for any college and would deal with case with minimum quorum of 4 members of 7 nominated for the committee.

The committee would have right to summon any student/staff etc, call for evidences, visit any place in the campus, hear accused/alleging parties and third parties for evidence/witness and decide the issues and propose punishment, if so needed or warn/caution/consulate for counselling parties and to mitigate the situation to the satisfaction of all concerned.

If there is no complaint also, the committee should meet at least once in a quarter and maintain records thereof for the purpose of statutory authority, in case of demand.
